Training and Education

These procedures will be clearly indicated for every specific certificate. EIA currently offers certification for:

- CERTIFIED IRRIGATION DISTRIBUTOR
- CERTIFIED IRRIGATION MANUFACTURER
- CERTIFIED IRRIGATION TRAINING PROVIDER

Recognition

Apart from the recognition that industry professionals get when granted certification, the EIA offers members visibility and reputation via several fora. An great example of this are the EIA Awards: A contest open to all irrigation professionals who have built innovative products, equipment, sites, projects or designs that promote water and energy savings and / or bring innovation to the irrigation industry. The EIA further promotes the interests of its members during trade shows (SMAGUA, Galabau, EIMA...).

The Association is actively promoting the products, practices and services of irrigation professionals at the European Level, with an active Secretariat in Brussels.

What are the advantages of EIA Membership?
